## REPRODUCTION REQUEST FORM

### Indicating Material to be copied:

- Via email, post, or telephone you must communicate clearly and precisely the material you would like reproduced.
- For manuscript items please indicate the author/recipient of the item(s), the date of the item(s), and the collection name & call number
- Please note that the MHS staff cannot canvas collections to locate uncataloged materials on your behalf nor can they provide transcriptions of documents that are difficult to read.

### Limitations of Providing Reproductions:

- The MHS will not reproduce items that are too large or fragile, or items that exist in facsimile or microcopy.
- The MHS will not reproduce items in a way that violates U.S. Copyright law
- Requests for more than 75 total pages must be approved by the Head of Reader Services or Reference Librarian
- Accepted requests for more than 75 pages or orders that require additional staff preparation will incur an additional processing fee of \$15.00 per hour.

### Receiving copied material:

- Photocopies are mailed to researchers within four weeks of the date of the request
  - Please verify mailing address with library staff when turning in request
- Low-resolution scans are emailed to researchers within four weeks of the date of the request

### Pricing for Services:

- Photocopies are \$0.50 per page.
- Low resolution digital files are \$0.50 per frame.
- **There is a \$10.00 minimum charge for all remote reproduction requests.**
- Additional postage fees are assessed to mailed orders

### Use of Reproduced Material:

- Please note that all reproductions are for personal study/reference use only. They may not be donated or deposited in other libraries or archives, or made available to other researchers without the written permission of the Massachusetts Historical Society.
- Ownership of reproduced material does not imply permission to publish or quote from documents. It is the sole responsibility of the researcher to obtain formal written permission from the MHS or, when applicable, the appropriate copyright owner. Permission to cite, quote, or otherwise publish material held by the MHS should be requested in writing from:

- Please include detailed information on materials to be cited and your publication/distribution plans in your request.

### Statement on Copyright

The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material.
